**2024 ORDINANCE NEW ORDINANCE**

**AN ORDINANCE TO AMEND AND SUPPLEMENT CHAPTER 387 OF THE BLOOMFIELD TOWNSHIP CODE, PROVIDING PARKING FOR PHYSICALLY LIMITED PERSONS**

**BE IT ORDAINED**, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, as follows:

Section 1. Chapter 387, entitled: "PARKING FOR HANDICAPPED", Section 387-4A "Enumeration of restricted parking areas", of the Code of the Township of Bloomfield is hereby amended by the addition of the following:

- (730) 12 Walnut Street, East curb, starting at a point 716 feet North of the Northerly curb line of Montgomery Street running 20 feet North therefrom. Placard # P2753420
- (731) 122 Davey Street, West curb, starting at a point 465 feet North of the Northerly curb line of Belleville Avenue running 20 feet North therefrom. Placard # P2767863 (Apt. B)
- (732) 44 Lawrence Street, West curb, starting at a point 209 feet South of the Southerly curb line of Dodd Street and running 20 feet South therefrom. Placard #P2420475
- (733) 24 Floyd Avenue, West curb, starting at a point 230 feet South of the Southerly curb line of Grove Street and running 20 feet South therefrom. Placard #P2810002 (apt. 3<sup>rd</sup> Floor)
- (734) 30 Floyd Avenue, West curb, starting at a point 157 feet South of the Southerly curb line of Grove Street and running 20 feet South therefrom. Placard #P2738771
- (735) 233 Baldwin Street, South curb, starting at a point 28 feet East of the Easterly curb line of Ridge Avenue and running 20 feet East therefrom. Placard #P2718223
- (736) 11 Park Street, North curb, starting at a point 121 feet West of the Westerly curb line of Broad Street and running 20 feet West therefrom. Placard #P2753420 (Apt 31)

Section 2. All ordinances inconsistent herewith are hereby repealed.

Section 3. This ordinance shall take effect upon final passage and publication in accordance with the law.
