**AMENDING PRIOR RESOLUTION TO APPROVE PARTICIPATION WITH THE STATE OF NEW JERSEY SAFE AND SECURE COMMUNITIES GRANT PROGRAM ADMINISTERED BY THE DIVISION OF CRIMINAL JUSTICE, DEPARTMENT OF LAW AND PUBLIC SAFETY**

WHEREAS, on March 25, 2024 the Mayor and Council passed resolution #11956 authorizing the Safe and Secure Communities Grant Program with the amount of \$45,100.00 matching of fringe benefits which should have been \$45,150.00; and

WHEREAS, the resolution should read as follows; and

WHEREAS, the Township of Bloomfield wishes to apply for funding of approximately \$45,150 with a match of fringe benefits for a project under the State of New Jersey Safe and Secure Communities Grant Program; and

WHEREAS, the Mayor and Council have reviewed the accompanying application and have approved said request; and

WHEREAS, the project is a joint effort between the Department of Law and Public Safety and the Township of Bloomfield for the purpose described in the application.

**NOW, THEREFORE, BE IT RESOLVED**, by the Mayor and Council, of the Township of Bloomfield, County of Essex, State of New Jersey that:

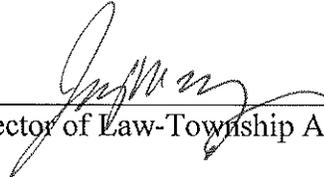
- As a matter of public policy the Township of Bloomfield wishes to participate to the fullest extent possible with the Department of Law and Public Safety and accept the grant funds.
- The Attorney General will receive funds on behalf of the applicant.
- The Division of Criminal Justice shall be responsible for the receipt and review of the applications for said funds.

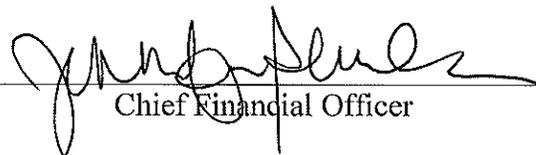
- The Division of Criminal Justice shall initiate allocations to each applicant as authorized.
