**2024 RESOLUTION - AWARD OF CONTRACT: THIRD RIVER URBAN PARK AND FLOOD PLAN CREATION PROJECT (PHASE 2 LION GATE) - CHANGE ORDER NO. 1 - FINAL**

**WHEREAS**, on May 18, 2020 the Township of Bloomfield entered into a contract with Your Way Construction, 404 Coit Street, Irvington, NJ 07111 (hereinafter “the Contractor”) in the amount of \$4,550,368.96 for the above referenced contract; and

**WHEREAS**, during the life of the contract, payments totaling \$4,317,127.25 have been made; and

**WHEREAS**, there is a last and final amount due in the amount of \$98,735.89, for a total payment amount of \$4,415,863.14; and

**WHEREAS**, after this final payment is made, there will be no more payments due to the Contractor; and

**WHEREAS**, Change Order No. 1 - Final represents a decrease to the contract in the amount of \$134,505.82 for a revised contract amount of \$4,415,863.14 or a decrease of 3.0 percent; and

**WHEREAS**, the Mayor and Council, based on the recommendation of the Township Director of Finance is satisfied that the Change Order should be approved; and

**WHEREAS**, this Change Order was found to be beneficial and necessary; and

**WHEREAS**, the Chief Financial Officer certifies that funding is available within capital account C-04-55-183-400.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey that Change Order No. 1 - Final is hereby approved and the Financial Officer of the Township of Bloomfield is hereby authorized to adjust the contract award for this final amount.
