**2024 RESOLUTION CHANGE ORDERS**

**2024 RESOLUTION - CONTRACT AMENDMENT - ENGINEERING DESIGN SERVICES FOR REPLACEMENT OF A SANITARY SEWER LINE UNDER THE GARDEN STATE PARKWAY BETWEEN JFK DRIVE NORTH AND SPRUCE STREET**

**WHEREAS**, the Township of Bloomfield needed to acquire professional services for Design, Bid Services, Construction Administration and Inspection to assess and evaluate an aging sanitary sewer line under the Garden State Parkway between JFK Drive North and Spruce Street which will require replacement; and

**WHEREAS**, the Township previously awarded a contract to Alaimo Group, 200 High Street, Mt. Holly, NJ 08060. (the Consultant) in the amount of \$88,000 under Contract No. 23-00136 ; and

**WHEREAS**, due to the sewer's location under the Garden State Parkway, traditional, open trench replacement is not viable due to severe impacts to traffic along the Parkway; and

**WHEREAS**, an alternative, known as "pipe busting" was anticipated, for this replacement but after further investigation and review by the NJ Turnpike Authority, this method was not considered viable; and

**WHEREAS**, the consultant is requesting an amendment to their contract in the amount of \$23,420.00 to explore further options in the repair or replacement of this sewer; and

**WHEREAS**, it is the recommendation of the Township Engineer that this amendment to contract 23-00136 be approved for an increase of \$23,420.00; and

**WHEREAS**, the Director of Finance has indicated that funding is available in Township Account Number C-04-55-232-902.

**NOW THEREFORE, BE IT RESOLVED**, that the Mayor and Council of the Township of Bloomfield hereby authorize the Township Engineer to amend Contract 23-00136 for an increase the contract amount by \$23,420.00.




