2024 RESOLUTION AWARD OF CONTRACT

2024 RESOLUTION EMERGENCY REPAIR AUTHORIZATION - VICINITY OF 49 PARK AVENUE

WHEREAS, on February 26, 2024, the Engineering was notified by the DPW Water and Sewer Supervisor indicating a collapse of a sanitary sewer manhole in the ; vicinity of 49 Park Avenue and

WHEREAS, the collapse was causing sewer back-ups into the properties serviced by the sewer line and the Sewer Department personnel were having difficulty clearing the line; and

WHEREAS, a utility contractor, Montana Construction, 80 Contant Avenue, Lodi, NJ 07644 (the "Contractor") was retained to perform the work; and

WHEREAS, The work commenced on February 29, 2024 and included the following:

1. By-pass pumping of the sewer line before and during replacement.
2. Excavation of the work area and disposal of excavated materials.
3. Installation of a new 48-inch diameter pre-cast manhole.
4. Installation of 9 linear feet of 8-inch diameter sewer main.
5. Backfill and restoration of the area after completion of the replacement.
6. Police traffic directors to properly direct and detour traffic.

WHEREAS, the total amount of the work was \$33,081.33; and

WHEREAS, the cost of the work was reviewed by the Bloomfield Engineering Department and found to be consistent with the work performed in the field; and

WHEREAS, the Chief Financial Officer has certified the availability of funds to pay the contract in capital account C-04-55-232-902; and

WHEREAS, pursuant to the provisions of N.J.S.A. 40A: 11-6 and the Township Code, the approval of the Council of the Township of Bloomfield is required in order to make payment to the vendors, for the contract price of the Services.


NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE TOWNSHIP OF BLOOMFIELD:

1. That payment to the contractor be made part hereof, at the contract prices for the emergency work in the vicinity of 49 Park Avenue in the aggregate amount not to exceed \$33,081.33 is hereby approved.

2. That this work be designated an emergency due to the fact that sewer service in this area was compromised resulting in backup of sanitary sewage into buildings as well as the potential of back-up onto the roadway.
3. That said payment represents the total cost of the work.
4. That the Clerk of the Township of Bloomfield forward two (2) certified copies of this resolution to the Chief Financial Officer and one copy to the Township Engineer.


