**2024 RESOLUTION - AWARD OF CONTRACT - IMPROVEMENTS TO DODD STREET & WATSESSING AVENUE - 2023 NJDOT MUNICIPAL AID PROGRAM (LA2023MA)**

**WHEREAS**, after the required legal advertising was published, sealed bids were received in the Council Chambers of the Municipal Building, Bloomfield, New Jersey on July 30, 2024 by the Purchasing Committee of the Township of Bloomfield in accordance with N.J.S.A. 40A:11-1 et seq., "Local Public Contracts Law" for Roadway Improvements to Dodd Street and Watsessing Avenue; and

**WHEREAS**, a total of four (4) bids were received with the lowest bid being submitted by J.A. Alexander, 130 JFK Drive North, Bloomfield, NJ 07003 (the "contractor") as follows:

Base Bid: \$795,588.63  
Alternate A: \$227,800.00  
  
TOTAL: \$1,023,388.63; and

**WHEREAS**, after review of the bids it was determined that the contractor's bid was complete and responsive; and

**WHEREAS**, this project was awarded a NJDOT Local Aid Grant in the amount of \$833,913.00 (LA2023MA); and

**WHEREAS**, it is the recommendation of the Township Engineer, that the project be awarded to J.A. Alexander, 130 JFK Drive North, Bloomfield, NJ 07003 for the base bid in the amount of \$795,588.63; and

**WHEREAS**, the Director of Finance has indicated that funding is available through the 2023 New Jersey Transportation Local Aid Grant Account No. G-02-40-302-027.

NOW THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey hereby accepts the recommendation of the Township Engineer and they may enter into a contract for the above improvements with J.A. Alexander, 130 JFK Drive North, Bloomfield, NJ 07003 for the base bid in the amount of \$795,588.63.
