**RESOLUTION AUTHORIZING THE TOWNSHIP OF BLOOMFIELD TO RESCIND
RESOLUTION # R24-266 WHICH AWARDED A CONTRACT TO AMERICAN
ASPHALT & TRUCKING, LLC FOR 2023-2024 CAPITAL ROADWAY PROGRAM -
JOHN F. KENNEDY DRIVE**

WHEREAS, the Township Council of the Township of Bloomfield previously voted by Resolution #R24-266 to award to American Asphalt & Trucking, LLC a contract for 2023-2024 Capital Roadway Program - John F. Kennedy Drive which encompassed among other service milling and repaving of JohnF. Kennedy Drive in certain locations; and

WHEREAS, Paul Lasek, P.E., Township Engineer, had discovered after the award of the contract that American Asphalt & Trucking LLC was entered onto the New Jersey Department of Labor's website on the Debarment List; and

WHEREAS, after further inquiry to the New Jersey Department of Labor, it was confirmed that American Asphalt & Trucking, LLC had its Public Works Contractor Registration suspended for a period of two (2) years; and

WHEREAS, all contractors conducting public works projects in the Township are required to have and maintain in good standing a Public Works Contractor Registration with the New Jersey Department of Labor; and

WHEREAS, being debarred or suspended effectively disqualifies American Asphalt & Trucking LLC from undertaking the work necessary to complete the project as awarded; and

WHEREAS, the Township Council desires to rescind Resolution # R24-266 and the contract between the Township and American Asphalt & Trucking LLC due to the suspension of the Public Works Contractor Registration.

NOW THEREFORE BE IT RESOLVED, by the Township Council of the Township of Bloomfield that the Township Clerk is hereby authorized to rescind Resolution # R24-266 and that Township Administration is to void any and all contracts executed between the Township and American Asphalt & Trucking LLC; and

Be it further resolved, that the Township Engineer immediate undertake such efforts as necessary to re-bid for the services related to 2023-2024 Capital Roadway Program - John F. Kennedy Drive




