**RESOLUTION - AWARD OF CONTRACT FOR PARK FENCING UPGRADES PHASE 2  
AT CLARKS POND SOUTH**

**WHEREAS**, the Township of Bloomfield has a thriving municipal park system that is used daily by residents and visitors alike; and

**WHEREAS**, over time, certain amenities in the parks need to be replaced due to wear and tear and exposure to the elements: and

**WHEREAS**, the Bloomfield Parks, Recreation & Cultural Affairs Department's goal is to upgrade various amenities within the parks to improve safety, functionality and keep them visually appealing and;

**WHEREAS**, the Bloomfield Parks, Recreation & Cultural Affairs Department Director has deemed that additional athletic field and perimeter fencing at Clarks Pond South, 111 Dewey St., Bloomfield, NJ 07003 is in need of replacement; and

**WHEREAS**, the Township of Bloomfield has received a NJ DEP Green Acres Supplemental Grant to fund this project; and

**WHEREAS**, in accordance to N.J.S.A. 40A:11-1 et seq., "Local Public Contracts Law" the Township can award the services of a company that possess a Local, State or National Purchasing Cooperative without needing to publicly bid the work; and

**WHEREAS**, Challenger Fence Inc., 100 Pennsylvania Ave., Paterson, NJ 07503 currently holds the Morris County Cooperative Pricing Council Contract #53 for fencing

**WHEREAS**, Challenger Fence Inc., 100 Pennsylvania Ave., Paterson, NJ 07503, has supplied a cost proposal to provide brand new athletic field and perimeter fencing, including removal and installation, at Clarks Pond South, 111 Dewey St., Bloomfield, NJ 07003; and


**WHEREAS**, the Director of Finance has indicated that funding is available in account #G-02-40-211-005 in the amount of \$117,450.00; and

**WHEREAS**, it is the recommendation of the Bloomfield Parks, Recreation & Cultural Affairs Director that the contract be awarded to Challenger Fence Inc., 100 Pennsylvania Ave., Paterson, NJ 07503 through the Morris County Cooperative Pricing Council Contract #53 to remove and install new athletic field fencing at Clarks Pond South, 111 Dewey St., Bloomfield, NJ 07003, NJ 07003 in the amount not to exceed \$117,450.00


