2024 RESOLUTION AWARD OF CONTRACT

RESOLUTION: AUTHORIZING THE AWARD OF A PROFESSIONAL SERVICE CONTRACT PURSUANT TO THE FAIR AND OPEN PROCESS FOR A RECREATION ENGINEERING CONSULTANT FOR 2023 LOCAL RECREATION IMPROVEMENT GRANT IMPLEMENTATION

WHEREAS, Premier Product Development, LLC, 18 West Walnut Ave., Moorestown, NJ 08057 ("PPD") has previously submitted a RFP to provided Recreation Engineering Consulting Services for the Township of Bloomfield and was approved to provide such services; and

WHEREAS, the Township of Bloomfield requires the services of Engineering and Design Consultants to administer and oversee the 2023 Local Recreation Improvement Grant for installation of shade structures at Lion Gate Park, 1 Lion Gate Drive, Bloomfield, NJ 07003; and

WHEREAS, the Township Administrator has certified in writing that the value of the service will exceed \$17,500; and

WHEREAS, PPD Design, (hereinafter "Professional") has submitted a proposal to provide said services; and

WHEREAS, after review and evaluation of the proposal it is recommended that a contract for the services be awarded to PPD in an amount not to exceed \$20,000.00; and

WHEREAS, the services provided by PPD will be solely for the aforementioned purposes and will be completed within (1) one year; and

WHEREAS, the Director of Finance has certified that funds are available

to cover the cost of these services in Recreation Capital Account #C-04-55-232-901; and

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Township of Bloomfield authorizes and directs the Bloomfield Parks, Recreation & Cultural Affairs Department Director to enter into a contract agreement with the PPD within 10 days as described herein; and

BE IT FURTHER RESOLVED, that this contract/retainer agreement is entered into in accordance with the Standardized Submission Requirements for Professional Services and no minimum payment is implied or guaranteed; and

BE IT FURTHER RESOLVED, that all of the terms contained in the Standardized Submission Requirements for Professional Services are incorporated into the Professional's contract unless specifically excluded; and


BE IT FURTHER RESOLVED, that in accordance with Standardized Submission Requirements the Township reserves the right to cancel this contract upon thirty (30) days notice and the Professional shall only be paid for the work completed or on a pro-rated amount if the contract calls for a monthly retainer; and

BE IT FURTHER RESOLVED, that the Professional's response to the request for Professional Services shall be placed on file with this resolution and a copy of the contract/retainer agreement entered into; and

BE IT FURTHER RESOLVED, that the contract should incorporate the terms and conditions contained in Professional's response to the request for Professional Services.


