RESOLUTION - AWARD OF CONTRACT FOR ALUMINUM BLEACHERS AT VASSAR FIELD

WHEREAS, the Township of Bloomfield has a thriving municipal park system that is used daily by residents and visitors alike; and

WHEREAS, over time, certain amenities in the parks need to be replaced due to wear and tear and exposure to the elements: and

WHEREAS, the Bloomfield Parks, Recreation & Cultural Affairs Department's goal is to upgrade various amenities within the parks to improve safety, functionality and keep them visually appealing and;

WHEREAS, the Bloomfield Parks, Recreation & Cultural Affairs Department Director has deemed that the Aluminum Bleachers at Vassar Field, 606 East Passaic Ave., Bloomfield, NJ 07003 and Clarks Pond South, 111 Dewey Street, Bloomfield, NJ 07003 are in need of replacement; and

WHEREAS, the Township of Bloomfield has received a NJ DEP Green Acres Supplemental Grant to fund this project; and

WHEREAS, in accordance to N.J.S.A. 40A:11-1 et seq., "Local Public Contracts Law" the Township can award the services of a company that possess a Local, State or National Purchasing Cooperative without needing to publicly bid the work; and

WHEREAS, Ben Shaffer Recreation, PO Box 844, Lake Hopatcong, NJ 07849

currently holds the NJ State Contract #16-FLEET-00135 for ADA Series Bleacher with Chain-link Guardrails; and

WHEREAS, Ben Shaffer Recreation, PO Box 844, Lake Hopatcong, NJ 07849, has supplied a cost proposal to provide (6) six ADA Series Aluminum Bleachers with chain-link guardrails, including delivery; and


WHEREAS, the Director of Finance has indicated that funding is available in account #G-02-40-211-005 in the amount of \$55,875.37; and

WHEREAS, it is the recommendation of the Bloomfield Parks, Recreation & Cultural Affairs Director that the contract be awarded to Ben Shaffer Recreation, PO Box 844, Lake Hopatcong, NJ 07849 through NJ State Contract #16-FLEET-00135 for (6) six ADA Series Bleacher Chain-link Guardrails in the amount not to exceed \$55,875.37.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey hereby accept the recommendation of Bloomfield Parks, Recreation & Cultural Affairs Director to award a contract to Ben Shaffer Recreation, PO Box 844, Lake Hopatcong, NJ 07849 through NJ State Contract #16-FLEET-00135 for (6) six ADA Series Bleacher Chain-link Guardrails in the amount not to exceed \$55,875.37.


