

#2 - NORTH ELEVATION







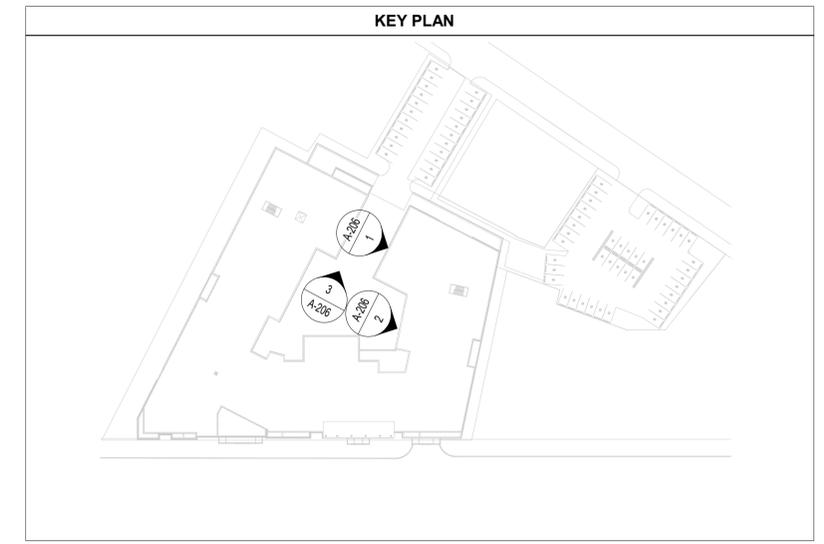
