2024 RESOLUTION AWARD OF CONTRACT

2024 RESOLUTION - AWARD OF CONTRACT - 2024 CAPITAL ROADWAY PROGRAM - JFK DRIVE & STATE STREET

WHEREAS, after the required legal advertising was published, sealed bids were received in the Council Chambers of the Municipal Building, Bloomfield, New Jersey on August 27, 2024 by the Purchasing Committee of the Township of Bloomfield in accordance with N.J.S.A. 40A:11-1 et seq., "Local Public Contracts Law" for the 2024 Capital Roadway Program - JFK Drive & State Street; and

WHEREAS, this project is for the resurfacing of JFK Drive North from Myrtle Street to Dodd Street; JFK Drive from Liberty Street to Belleville Avenue and State Street from Belleville Avenue to Broad Street; and

WHEREAS, a total of seven (7) bids were received and were referred to the Township Engineer for review; and

WHEREAS, the lowest responsible bid was received by D & L Paving Contractors, 675 Franklin Ave., Nutley, NJ, 07110-1209 in the amount of \$352,336.19; and


WHEREAS, the bid was reviewed by the Township Engineer and found to be complete and responsive; and

WHEREAS, the Director of Finance has indicated that funding is available in the roadway capital account C-04-55-232-905.

NOW THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Township Of Bloomfield, County of Essex, State of New Jersey hereby accepts the recommendation of the Township Engineer and he may enter into a contract for the above improvements with D & L Paving Contractors, 675 Franklin Ave., Nutley, NJ, 07110-1209 in the amount of \$352,336.19.




