**RESOLUTION AUTHORIZING THE EXECUTION OF A CROSS-ACCESS EASEMENT AGREEMENT OVER A PORTION OF PROPERTIES LOCATED BLOCK 1111, LOTS 125 & 128**

**WHEREAS**, the Township of Bloomfield (the "Township") and the Church of St. Thomas the Apostle ("Church") desire to enter into a Deed of Easement in connection with property located at Block 1111, Lots 125 & 128, in the Township of Bloomfield, County of Essex in the form attached hereto as Exhibit "A";

**WHEREAS**, the property located at Block 1111, Lot 125 is owned by the Church and is commonly known as 55 Day Street ("Church Lot"); and

**WHEREAS**, the property located at Block 1111, Lot 128 is owned by the Township of Bloomfield and is commonly known as Vassar Field ("Township Lot"); and

**WHEREAS**, a driveway used to access both the Church Lot and Township Lot is situated partially on Church Lot and partially on Township Lot ("Driveway Easement"); and

**WHEREAS**, a portion of Day Street, a Bloomfield Township right-of-way, encroaches on the north-west corner of the Church Lot ("Day Street Easement"); and

**WHEREAS**, this Cross-Access Easement is being made to ensure reciprocal rights for both the Township and the Church to use the Driveway Easement and Day Street Easement; and

**WHEREAS**, the Church is willing to grant easement for the benefit of the Township over such portion of the Church Lot; and

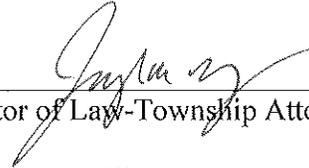
**WHEREAS**, the Township is willing to grant easement for the benefit of the Church over such portion of the Township Lot; and

**WHEREAS**, the parties have agreed to execute an Easement Agreement with each other.

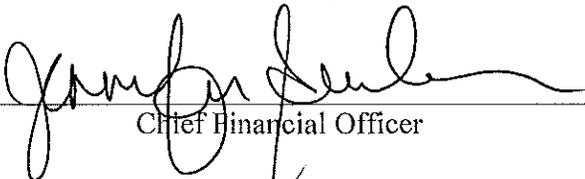
