**2024 RESOLUTION ABC TRANSFERS**

**A RESOLUTION APPROVING WAIVER OF 500 FOOT DISTANCE RESTRICTION BETWEEN PLENARY RETAIL CONSUMPTION LICENSE OPERATIONS**

**WHEREAS**, a Place-to-Place application has been made by Hometown Arcade LLC for Plenary Retail Consumption License #0702-33-007-008 to the Township Clerk; and

**WHEREAS**, the location sought by Hometown Arcade LLC is 85 Washington Street, Bloomfield ("Location"); and

**WHEREAS**, upon review by the Township Clerk it was determined that within 500 feet of the proposed Location, there existed at least two other Plenary Retail Consumption Licenses (Essex Junction and Aloha Crab); and

**WHEREAS**, the Township ordinance prohibits the placement of Plenary Retail Consumption Licenses within 500 feet of each other; and

**WHEREAS**, Hometown Arcade has requested by way of correspondence transmitted to the Township Clerk for relief from the prohibition under Ordinance 122-14; and

**WHEREAS**, the Township Council, after due consideration of all the factors in Ordinance 122-14, is of the opinion that the waiver of the 500 foot restriction for Hometown Arcade LLC is in the best interest of the municipality.

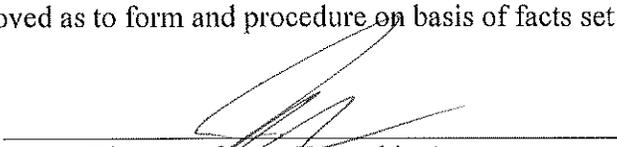

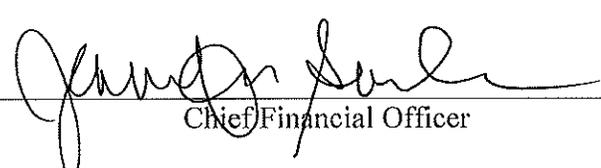

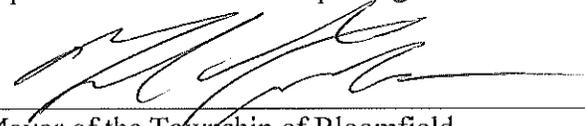
