2024 RESOLUTION AWARD OF CONTRACT

2024 RESOLUTION EMERGENCY REPAIR AUTHORIZATION - CATCH BASIN REPAIR AT THE INTERSECTION OF 1ST AVENUE AND NORTH 15TH STREET

WHEREAS, the Engineering Department was notified by the Public Works Department that a storm sewer catch basin at the above referenced intersection was collapsed and no longer functional; and

WHEREAS, inspection of the damage indicated that the catch basin needed to be replaced as well as the piping leading to the downstream storm connection; and

WHEREAS, due to the location of the basin, and the fact that this area is subject to localized flooding during rainstorms, the Engineering Department determined that the basin should be replaced immediately to avoid worsening of the localized flooding during a rain event; and

WHEREAS, due to the extensive nature of the work, it was further determined that a utility contractor would be required to perform the work; and

WHEREAS, a utility contractor, Frank Galbraith & Son Excavation & Demolition, LLC, 831 Raritan Road, Scotch Plains, NJ 07076; and

WHEREAS, the work included the following:

1. Excavation and disposal of backfill and asphalt material from the work area.
2. Installation of a new 8-foot deep catch basin, including a new steel casting and grate.
3. Restoration of the work area, including the following:
 - Replacement of granite block curbing.
 - Replacement of concrete sidewalk.
 - Restoration of the roadway area.
4. Police traffic direction and maintenance during the project.

WHEREAS, the work was completed in one day at a cost of \$27,000.00; and

WHEREAS, the cost of the work was reviewed by the Bloomfield Engineering Department and found to be consistent with the work performed in the field; and

WHEREAS, the Chief Financial Officer has certified the availability of funds to pay the contract in capital account C-04-55-233-501; and


WHEREAS, pursuant to the provisions of N.J.S.A. 40A: 11-6 and the Township Code, the approval of the Council of the Township of Bloomfield is required in order to make payment to the vendors, for the contract price of the Services.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE TOWNSHIP OF BLOOMFIELD:

1. That payment to the contractor be made part hereof, at the contract prices for the emergency work at the intersection of 1st Avenue and North 15th Street in the aggregate amount not to exceed \$27,000.00 are hereby approved.
2. That this work be designated an emergency due to the fact that this area is subject to localized flooding and a non-functional catch basin would result in additional flooding which would constitute a risk to public health and safety.
3. That said payment represents the total cost of the work.
4. That the Clerk of the Township of Bloomfield forward two (2) certified copies of this resolution to the Chief Financial Officer and one copy to the Township Engineer.


