**2024 RESOLUTION - AWARD OF CONTRACT - 2024-2025 SEWER VIDEO & CLEANING SERVICES**

**WHEREAS**, after the required legal advertising was published, sealed bids were received in the Council Chambers of the Municipal Building, Bloomfield, New Jersey on October 22, 2024 by the Purchasing Committee of the Township of Bloomfield in accordance with N.J.S.A. 40A:11-1 et seq., "Local Public Contracts Law" for 2024-2025 Sewer Video & Cleaning Services; and

**WHEREAS**, this contract involves providing on-call video services for the inspection of sanitary and storm sewer mains within the township; and

**WHEREAS**, this contract also involves on-call services for sewer cleaning and by-pass pumping in the event of a blockage within the various sewer mains.; and

**WHEREAS**, A single bid was received from Montana Construction Corp., 80 Contant Avenue, Lodi, New Jersey 07644 at the rates indicated in their proposal; and

**WHEREAS**, the bid was reviewed by the Township Engineer and found to be complete and responsive; and

**WHEREAS**, the rates provided are consistent with past rates the township has received from other vendors, as well as this contractor; and

**WHEREAS**, it is recommendation of the Township Engineer that an annual contract be awarded to Montana Construction Corp. Inc., 80 Contant Avenue, Lodi, New Jersey 07664 at the rates provided in their proposal at a cost not to exceed \$100,000.00; and

**WHEREAS**, the Director of Finance has indicated that funding is available in the following accounts:


