**2025 RESOLUTION AWARD OF PROFESSIONAL SERVICE**

**RESOLUTION: APPROVAL OF DRAGONFLY INVESTMENT AS QUALIFIED TOWNSHIP REPRESENTATIVE CONSULTANTS FOR THE RENDERING OF SERVICES FOR THE TOWNSHIP OF BLOOMFIELD FOR 2025**

**WHEREAS**, the Township of Bloomfield has an ongoing need to contract with qualified Representative Consultant; and

**WHEREAS**, the Township has publicly advertised-via the Request for Qualifications (“RFQ”) process for such Township Representative Consultant; and

**WHEREAS**, the Township of Bloomfield has reviewed the Statements of Qualifications submitted in response to the Township’s RFQ; and

**WHEREAS**, The Township pursuant to the RFQ, now proposes to qualify Dragonfly Investment Group Associates Engineering to be eligible to serve as Township Representative Consultant and eventually enter into professional services contracts with same on a project matter; and

**WHEREAS**, the Director of Finance shall certify the availability of the funds to pay such contract(s) for Township Representative Consultant when such services are ordered; and

**WHEREAS**, said Consultants contracted may be awarded without public bidding as a professional services in accordance with N.J.S.A. 40A:11-5(a) of the Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq. on condition that a resolution authorizing such contracts without competitive bidding and the contracts themselves be made available for public inspection.

**NOW, THEREFORE, BE IT RESOLVED**, by the Mayor and Council, of the Township of Bloomfield, County of Essex, State of New Jersey as follows:
