**WHEREAS**, the Township of Bloomfield needs the ability to purchase various technology hardware, software, and support services throughout the Township; and

**WHEREAS**, in accordance with N.J.S.A. 40A:11-1 et seq., "Local Public Contracts Law" the Township may, without advertising for bids, purchase any goods or services under a contract entered into on behalf of the state and through specified federal procurement programs, and

**WHEREAS**, CDWG was awarded STATE CONTRACTS# ESCNJ/AEPA-22G AND Sourcewell 081419-CDW Tech Catalog (081419#CDW); and

**WHEREAS**, the Township IT Director has determined that the value of these services will exceed \$17,500; and

**WHEREAS**, the Director of Finance has indicated that funds are available to cover the cost of these services in account # 5-01-20-140-026.

**BE IT RESOLVED** that no minimum payment is implied or guaranteed.

**NOW, THEREFORE, BE IT RESOLVED** that the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, hereby accepts the recommendation of the Township Assistant Administrator / IT Director and authorizes the Township Assistant Administrator / IT Director to purchase such hardware, software, and support services not to exceed \$86,000.00 as needed with CDWG as described herein.
