WHEREAS, the Township IT Director has determined that the value of these services will exceed \$17,500; and

WHEREAS, JCT Solutions, located at 36 Commerce Street, Springfield, NJ 07081, was awarded a New Jersey State Contract T-0109 Solicitation # 13-X-22183; and

WHEREAS, JCT Solutions will provide 2025 renewal support services for Police Department Central Communications Vesta 911 Systems; and

WHEREAS, the Director of Finance has indicated that funds are available to cover the cost of these services in account # 5-01-20-140-026; and

WHEREAS, that no minimum payment is implied or guaranteed.

NOW, THEREFORE, BE IT RESOLVED that the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, hereby accepts the
