**2025 AWARD OF A CONTRACT TO GOLD TYPE BUSINESS MACHINE GTBM NETCLOUD FOR PROFESSIONAL SUPPORT OF POLICE GOLD TYPE BUSINESS MACHINE UNDER BERGEN COOP-BID 23-17 FOR E-TICKET SERVICE AND INFO-COP SOLUTIONS**

**WHEREAS**, the Township of Bloomfield Police Department needs the services of professional support of their GTBM NetCloud, Bergen COOP-BID 23-17 for E-ticket Service/Info-Cop Solutions; and

**WHEREAS**, in accordance with N.J.S.A, 40A:11-1 et seq., "Local Public Contracts Law," the Township may, without advertising for bids, purchase any goods or services under a contract entered into on behalf of the State of New Jersey and through specified federal procurement programs; and

**WHEREAS**, the Township Police Chief has determined that the value of these services will exceed \$17,500; and

**WHEREAS**, Gold Type Business Machine GTBM NetCloud located at 351 Paterson Ave., East Rutherford, NJ 07073; and

**WHEREAS**, the Director of Finance has certified that funds are available to cover the cost of this service in an amount not to exceed \$28,000 in account# 5-01-20-140-026; and

**BE IT RESOLVED** that no minimum payment is implied or guaranteed.

**NOW, THEREFORE, BE IT RESOLVED** that the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, hereby accepts the recommendation of the Township Police Chief and authorizes the Police Chief or his designee to

contract with GTMB NetCloud for services Info-Cop and E-ticket services not to exceed

\$28,000.00, as described herein.
