**2025 RESOLUTION AMENDING RESOLUTION R25-27 AND MODIFYING THE MEMBERSHIP OF THE BLOOMFIELD SENIOR CITIZEN ADVISORY COMMITTEE**

**WHEREAS**, the Mayor and Township Council via Resolution R25-27 have established an advisory committee for the purpose of having community representatives serve in an advisory capacity to provide recommendations and advise the Township on building a culture of awareness and organizing events and programs to meet the needs of Bloomfield's Senior Citizen population; and

**WHEREAS**, the duty and function of the Committee shall be to advance, through community effort or otherwise, education and awareness among the community and to make recommendations to the Mayor, Township Council and Township Division of Human Services for the development of programs that will aid in identifying the needs and supporting the welfare of Bloomfield's Senior Citizen Community. The Committee will be advisory in capacity and will not be responsible for budget, operations, programing, or fundraising, but may consult with Township Staff and Officials as needed and/or requested; and

**WHEREAS**, the Mayor and Township Council wish to modify the committee membership: the Committee shall consist of six (6) residents of the Township, each of whom shall be appointed by the Mayor, one (1) Township Administration representative, and one (1) Township Council liaison; and

**WHEREAS**, each Committee Member, Township Administration representative, and the Council Liaison shall be appointed to a term of one (1) year, or until a replacement is appointed, and vacancies shall be filled by the Mayor only for the unexpired term; and

**WHEREAS**, The Committee shall meet at least quarterly and the members of this Committee shall not receive compensation for their services.

NOW, THEREFORE BE IT RESOLVED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, there shall be a Senior Citizen Advisory Committee.
