2025 RESOLUTION AWARD OF CONTRACT

RESOLUTION: 2025 AWARD OF CONTRACT TO JCT SOLUTIONS, UNDER UCCP 8-2022 INFRASTRUCTURE, FIBER OPTIC NETWORK ADVANCED APPLICATIONS AND SERVICES FOR INSTALLATION OF AN ALPR SYSTEM

WHEREAS, the Bloomfield Police Department needs the ability to purchase Materials and Software for the installation of an ALPR System; and

WHEREAS, in accordance with N.J.S.A. 40A:11-1 et seq., "Local Public Contracts Law," the Township may, without advertising for bids, purchase any goods or services under a contract entered into on behalf of the state and through specified federal procurement programs; and

WHEREAS, JCT Solutions, located at 36 Commerce Street, Springfield, NJ 07081, was awarded UCCP 8-2022 Infrastructure, Fiber Optic Network Advanced Applications and Services; and

WHEREAS, JCT Solutions will provide the Materials, Installation, and Software for the installation of this ALPR System; and

WHEREAS, the Township IT Director has determined that the value of these services will exceed \$17,500; and

WHEREAS, the Director of Finance has indicated that funds are available to cover the cost of these services in the amount of \$55,878.40 from account # C-04-55-235-100; and

BE IT RESOLVED, that no minimum payment is implied or guaranteed, and

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, hereby accepts the

recommendation of the Police Chief and authorizes the Police Chief to contract with JCT

Solutions for Installation of an ALPR System and installation not to exceed \$55,878.40 as needed with JCT Solutions, as described herein.
