**AUTHORIZING THE DISCHARGE OF RESIDENTIAL REHABILITATION PROGRAM MORTGAGE LIENS ON 9 WELLS COURT IN THE TOWNSHIP OF BLOOMFIELD**

**WHEREAS**, the Township's Residential Rehabilitation program provided funding for home improvement projects to qualified homeowners within the Township of Bloomfield; and

**WHEREAS**, funding was provided to Daniel Gray, the homeowner of 9 Wells Ct. (the "Property") in 2009; and

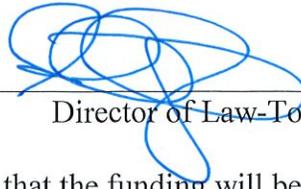
**WHEREAS**, in return for the loan, the Property was Mortgaged to the Township of Bloomfield and a Mortgage Lien was recorded in the Office of the Essex County Register and filed in Book 12243 Page; 5486; and

**WHEREAS**, the terms of the Mortgage Lien and Homeowner's Agreement have been satisfied and may be discharged.

**NOW, THEREFORE, BE IT RESOLVED**, that the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey hereby authorize and direct the Township Administrator, or his designee, to sign any documents that are necessary to discharge mortgage lien/agreement held by the Township of Bloomfield in connection with 2009 funding for 9 Wells Ct.

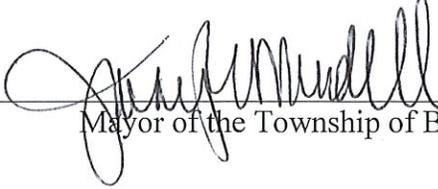
