2025 RESOLUTION - SOLID WASTE & RECYCLING COLLECTION SERVICES FOR THE TOWNSHIP OF BLOOMFIELD - CONTRACT EXTENSION

WHEREAS, The Township of Bloomfield currently has a contract with Suburban Disposal, Inc., 54 Montesano Road, Fairfield, NJ 07004, for Solid Waste Collection Services for the Township of Bloomfield; and

WHEREAS, the current contract will expire in 2025; and

WHEREAS, the original bid proposal provided an option to continue this contract for two more years at the following bid rates:

Base Bid:

Year 4 \$3,495,000.00 (Option, Year #1)
Year 5 \$3,635,000.00 (Option, Year #2)

Roll Off Service:

Table with columns for 30 Cubic Yard Container and 40 Cubic Yard Container, and rows for Year 4 and Year 5 pricing.

On-Call Vehicle Rental:

Table with columns for Hourly Rate and Daily Rate, and rows for Year 4 and Year 5 pricing.

WHEREAS, after review of the proposed pricing for the next two years, it was the recommendation of the Township Engineer that this contract be extended at the given Options for year 4 and year 5 (Option Year 1 and Option Year 2); and

WHEREAS, funding is available within the township's operating budget for solid waste and recycling collection services.

NOW THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, hereby extend the current contract for the collection of solid waste services to Suburban Disposal, Inc., 54 Montesano Road, Fairfield, NJ 07004 at the given rates as described above.


