2025 AUTHORIZING RESOLUTION FOR THE EXECUTION OF A NJDEP TREATMENT WORKS APPROVAL FOR A SANITARY SEWER EXTENSION FOR 675-699 BLOOMFIELD AVENUE; 14 & 34-40 STATE STREET, BLOCK 244, LOTS 10,42 & 46

WHEREAS, the New Jersey Department of Environmental Protection (NJDEP) Bureau of Construction requires a permit from the NJDEP Division of Water Quality for construction of a sanitary sewer extension for the above redevelopment project; and

WHEREAS, CBD Bloomfield Developer Urban Renewal, 75 Eisenhower Parkway, Suite 180, Roseland, NJ 07068 as the applicant, is requesting endorsement from a representative of the Township of Bloomfield of form WQM-003 for extension of a sanitary sewer; and

WHEREAS, the purpose of the application is to obtain a Treatment Works Approval (TWA) from the NJDEP to provide sanitary sewer service to the redevelopment project. The project involves a six-story, mixed use, multifamily development with event space; and

WHEREAS, the application materials for this discharge were reviewed by Township Engineer and found to be acceptable.

NOW BE IT RESOLVED, by the Mayor and Township Council that the Township Engineer of the Township Of Bloomfield is hereby authorized to execute form WQM-003 for a NJDEP Treatment Works approval for sanitary sewer extension.
