**RESOLUTION AUTHORIZING THE APPOINTMENT OF CHRISTOPHER GAMBA TO THE POSITION OF FIREFIGHTER**

**WHEREAS**, Christopher Gamba filed an appeal with the Civil Service Commission (“CSC”) of his rejection as a Firefighter candidate by the Township of Bloomfield and the Township’s request to remove his name the eligible list for Fire Fighter on the basis of unfitness to perform the duties of a fire fighter; and

**WHEREAS**, by Order dated April 9, 2025 the CSC granted Christopher Gamba’s appeal and ordered that he be appointed to the position of Fire Fighter retroactive to March 26, 2024 with that day being only for the purpose of step placement and seniority and that he not receive any other relief such as back pay or counsel fees; and


**WHEREAS**, had Chirstopher Gamba been appointed as a fire fighter on March 26, 2024 he would currently be at step 2 of the salary ordinance for a fire fighter in the Township; and

**WHEREAS**, Mayor and Counsel wish to comply with the CSC Commission Order.

**NOW THEREFORE BE IT RESOLVED** , by the Mator and Council of the Township of Bloomfield that Chritopher Gamba shall be appointed to the position of Fire Fighter retroactive to March 26, 2024 for purposes of salary step and seniority only, however he shall not be entitled to back pay.


