**2025 RESOLUTION AUTHORIZATIONS**

**RESOLUTION: AUTHORIZING TAX APPEAL SETTLEMENT FOR GLEN RIDGE COUNTRY CLUB V. BLOOMFIELD TOWNSHIP**

**WHEREAS**, Glen Ridge Country Club owns the following properties located in Bloomfield Township: 799 Broad Street + Rear (Block 871; Lot 20); 882-932 Broad Street (Block 931; Lot 28); 797 Broad Street (Block 871; Lot 18); and Fitzherbert Street (Block 902; Lot 19) (hereinafter collectively referred to as “the Subject Property”); and

**WHEREAS**, Glen Ridge Country Club filed appeals to the Tax Court of New Jersey challenging the Subject Property's property tax assessments for tax years 2015 through 2023 and 2025; and

**WHEREAS**, the parties have engaged in discovery and settlement negotiations; and

**WHEREAS**, as a result of that discovery and settlement negotiations, a settlement has been reached upon the recommendation and concurrence of the Township Attorney, Municipal Tax Attorney, Township Appraiser and Township Assessor; and

**WHEREAS**, as part of the settlement, Glen Ridge Country Club has agreed to withdraw the 2020, 2021 and 2022 tax appeals of the Subject Property; and

**WHEREAS**, Glen Ridge Country Club has agreed to waive all interest due on any refund providing that same is paid by the municipality within sixty (60) days from the date of entry of the Tax Court Judgment; and

**WHEREAS**, the Township Attorney, Municipal Tax Attorney, Township Appraiser and the Tax Assessor have all recommended said settlement to the Township Council; and

**WHEREAS**, the Township Council is of the opinion that said settlement is in the best

**NOW, THEREFORE, BE IT RESOLVED**, by the Mayor and Township Council of Bloomfield Township, County of Essex, State of New Jersey, that settlement of the pending tax appeal is hereby authorized as follows:
