2025 RESOLUTION AMENDING RESOLUTION R25-29 TO MODIFY THE NAME OF THE FIESTA LATINA AND HISPANIC HERITAGE MONTH ADVISORY COMMITTEE TO THE BLOOMFIELD HISPANIC HERITAGE COMMITTEE

WHEREAS, the Mayor and Township Council via Resolution R25-29 established an advisory committee for the purpose of having community representatives serve in an advisory capacity to provide recommendations and advise the Township on building a culture of awareness and organizing events celebrating Hispanic Heritage and Fiesta Latina; and

WHEREAS, the Mayor and Township Council wish to rename the committee the “Bloomfield Hispanic Heritage Committee” because the purpose of the committee is not just related to Hispanic Heritage Month and Fiesta Latina but instead to advance Hispanic Heritage, through community effort or otherwise, education, cultural awareness, and celebration among the community and to make recommendations to the Mayor and Township Council for the development of programs that will aid in building recognition and appreciation of Hispanic Heritage and Fiesta Latina.

NOW, THEREFORE BE IT RESOLVED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, that the name of the Bloomfield Fiesta Latina and Hispanic Heritage Month Advisory Committee is hereby changed to the “Bloomfield Hispanic Heritage Committee”; and

Be IT FURTHER RESOLVED that the balance of R25-29 shall remain in full force and effect.
