### CONDITIONS OF APPLICATION

**BY SIGNING THIS APPLICATION, I ACKNOWLEDGE AND UNDERSTAND THE FOLLOWING FACTS, TERMS AND POLICIES RELATED TO THE REQUESTED SIDEWALK AND/OR CURB REPAIR:**

1. I am the legal owner of the property for which the repair is being requested.
2. To the best of my knowledge, the requested repair meets the requirements of the Township's sidewalk & curb repair policy in that it has been lifted or damaged due to a township tree within the township right-of-way.
3. **THE TOWNSHIP IS IN NO WAY OBLIGATED TO PERFORM THIS WORK.** The Township Sidewalk Replacement Program is performed as a courtesy to residents and is performed based upon available capital funding and design/construction availability. Scheduling of repairs is performed based upon the order in which the requests are received. However, the Township Engineer has the right to deny or alter the schedule of sidewalk and curb repairs at their discretion.
4. I acknowledge that in accordance to the Township Code, Section 497-16A, *the installation, repair or replacement of curbs and sidewalks is the responsibility of the abutting property owner.* Signing and submitting this application IN NO WAY RELIEVES THE PROPERTY OWNER OF THEIR RESPONSIBILITIES REGARDING MAINTENANCE AND REPAIR OF SIDEWALK AND/OR CURBING. THE TOWNSHIP IS IN NO WAY GRANTING A WAIVER OF THE REQUIREMENTS OF SECTION 497-16A TO THE APPLICANT OF THIS REQUEST. ALL LIABILITY RELATED TO THE CONDITION OF THE SIDEWALK REMAINS WITH THE PROPERTY OWNER.
5. If the Township proceeds with a sidewalk and curb repair program in any given year, and if the requested location is approved for replacement, it will be performed at no cost to the property owner.
