2025 RESOLUTION GRANT AGREEMENTS

RESOLUTION: AUTHORIZING THE SUBMISSION OF AN APPLICATION TO THE NJDCA RECREATIONAL OPPORTUNITIES FOR INDIVIDUALS WITH DISABILITIES PROGRAM FY2026

WHEREAS, the Township of Bloomfield desires to apply for and obtain a grant from the New Jersey Department of Community Affairs for approximately \$20,000 to carry out a project to provide inclusive recreation opportunities for individuals with developmental disabilities as part of Bloomfield's programming to benefit such individuals ages four through adult; and

BE IT THEREFORE RESOLVED, that the Municipal Council of the Township of Bloomfield

- 1) does hereby authorize the application for such a grant; and,
- 2) recognizes and accepts that the Department may offer a lesser or greater amount and therefore, upon receipt of the grant agreement from the New Jersey Department of Community Affairs, does further authorize the execution of any such grant agreement; and also, upon receipt of the fully executed agreement from the Department, does further authorize the expenditure of funds pursuant to the terms of the agreement between the Township of Bloomfield and the New Jersey Department of Community Affairs.
