2025 RESOLUTION AWARD OF PROFESSIONAL SERVICE

RESOLUTION APPROVING CME ASSOCIATES AS QUALIFIED RECREATION ENGINEERING SERVICE FOR THE RENDERING OF SERVICES TO THE TOWNSHIP OF BLOOMFIELD FOR 2026

WHEREAS, The Township of Bloomfield, has an ongoing need to contract with a qualified Recreation Engineer Service in the State of New Jersey for the provision of said services for the Township; and

WHEREAS, the Township has publicly advertised via the Request of Qualifications (RFQ) process for such Recreation Engineer Consultant; and

WHEREAS, the Township has reviewed the Statements of Qualifications submitted in response to the Township RFQ; and

WHEREAS, the Township pursuant to the responses to the RFQ, now proposes to qualify CME Associates to be eligible to serve as Recreation Engineer and eventually enter into a professional services contract; and

WHEREAS, the Director of Finance shall certify that the availability of the funds to pay such contract for Recreation Engineer when such services are supplied to the Township;

WHEREAS, said Recreation Engineer contract may be awarded without public bidding as a professional services in accordance with N.J.S.A.40A:11-5(a) of the Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq. on condition that a resolution authorizing such contracts without competitive bidding and the contracts themselves be made available for public inspection.

NOW, THEREFORE, BE IT RESOLVED, AS FOLLOWS:

1. That the Township of Bloomfield, hereby authorized, a Recreation Engineer, to enter into professional services contracts with CME Associates for the provision of said services during the calendar year 2026.
2. That the Township of Bloomfield is authorized to contract with this Recreation Engineer for the provision of qualified Recreation Engineer Service, subject to Governing Body approval, without competitive bidding in accordance with N.J.S.A. 40A:11-5(1)(A) of the Local Public Contracts Law.
