2025 RESOLUTION APPROVAL

RESOLUTION OF THE MAYOR AND COUNCIL OF THE TOWNSHIP OF BLOOMFIELD, IN THE COUNTY OF ESSEX, STATE OF NEW JERSEY AUTHORIZING THE EXECUTION OF A CERTIFICATE OF COMPLETION TO ROYAL URBAN RENEWAL, LLC FOR THE REDEVELOPMENT PROJECT LOCATED ON PROPERTIES DESIGNATED AS BLOCK 227, LOTS 12 AND 24 (f/k/a Lots 1, 12, 24, 26, 30, 31, 32 and 35) ON THE TAX MAPS OF THE TOWNSHIP OF BLOOMFIELD

WHEREAS, Royal Urban Renewal, LLC (the "Redeveloper"), pursuant to the Redevelopment Agreement with the Township of Bloomfield (the "Township"), dated as of October 15, 2018 (the "Redevelopment Agreement") undertook certain work at Block 227, Lots 12 and 24 (f/k/a Lots 1, 12, 24, 26, 30, 31, 32 and 35), in the Township of Bloomfield, County of Essex, New Jersey, as shown on the tax maps of the Township (collectively the "Property"); and

WHEREAS, the Redeveloper completed the redevelopment of the Property through the construction of fourteen (14) two-story townhomes, mixed-use building with approximately 7,170 square feet of ground floor retail space and 199 residential units on the upper floors, a parking garage with approximately 311 parking spaces, and related improvements (the "Project"); and

WHEREAS, the Redevelopment Agreement provides that upon completion of the Project, the Redeveloper may apply for a Certificate of Completion, which recognizes that the work has been completed and releases the Redeveloper from their responsibilities under the Redevelopment Agreement as to the Project; and

WHEREAS, the Redeveloper has requested that the Township issue a Certificate of Completion for the Project and submits that it has complied with all requirements of the Redevelopment Agreement, has completed the Project in accordance with the final site plan approved by the Township of Bloomfield Planning Board (the “**Planning Board**”), and has obtained Certificates of Occupancy with respect to the Project; and

WHEREAS, the Redeveloper undertook the necessary construction, and has complied with all requirements of the Redevelopment Agreement, Redevelopment Plan, and the final site plan approval issued by the Planning Board, and has obtained Certificates of Occupancy for the entirety of Project; and

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Bloomfield, New Jersey as follows:

Section 1. The recitals are hereby incorporated herein as if set forth at length.

Section 2. The Township Council hereby consents to the execution of a Certificate of Completion, as set forth herein, in accordance with the terms of the Redevelopment Agreement.

Section 3. The Township Council hereby authorizes and directs the Mayor to execute the Certificate of Completion on behalf of the Township, as necessary to further evidence or acknowledge the Township’s consent.

Section 4. This resolution shall take effect immediately.
