2025 RESOLUTION AWARD OF PROFESSIONAL SERVICE

RESOLUTION: APPROVING ALOIA LAW FIRM LLC QUALIFIED HEARING OFFICER FOR THE RENDERING OF SERVICES TO THE TOWNSHIP OF BLOOMFIELD FOR 2026

WHEREAS, The Township of Bloomfield, has an ongoing need to contract with qualified Hearing Officer in the State of New Jersey for the provision of said services for the Township; and

WHEREAS, the Township has publicly advertised via the Request of Qualifications (RFQ) process for such Hearing Officer; and

WHEREAS, the Township has reviewed the Statements of Qualifications submitted in response to the Township RFQ; and

WHEREAS, the Township pursuant to the responses to the RFQ, now proposes to qualify Aloia Law Firm LLC to be eligible to serve as a Hearing Officer and eventually enter into a professional services contract; and

WHEREAS, the Director of Finance shall certify that the availability of the funds to pay such contract for Hearing Officer when such services are supplied to the Township;

WHEREAS, said Hearing Officer contract may be awarded without public bidding as a professional services in accordance with N.J.S.A.40A:11-5(a) of the Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq. on condition that a resolution authorizing such contracts without competitive bidding and the contracts themselves be made available for public inspection.

NOW, THEREFORE, BE IT RESOLVED, AS FOLLOWS:

1. That the Township of Bloomfield, hereby authorized, a Hearing Officer, to enter into professional services contracts with Aloia Law Firm LLC for the provision of said services during the calendar year 2026.
2. That the Township of Bloomfield is authorized to contract with this Hearing Officer for the provision of qualified Hearing Officer Service, subject to Governing Body approval, without competitive bidding in accordance with N.J.S.A. 40A:11-5(1)(A) of the Local Public Contracts Law.
