2025 RESOLUTION AWARD OF PROFESSIONAL SERVICE

RESOLUTION: APPROVAL OF PEM LAW LLP AS QUALIFIED ATTORNEYS, ELIGIBLE FOR SELECTION FOR THE RENDERING OF SPECIAL LEGAL COUNSEL SERVICES TO THE TOWNSHIP OF BLOOMFIELD FOR 2026

WHEREAS, the Township of Bloomfield has an ongoing need to contract with qualified Special Legal Counsel in the State of New Jersey for the provision of Legal Services for the Township of Bloomfield; and

WHEREAS, the Township has publicly advertised-via the Request for Qualifications ("RFQ") process for such Legal Services; and

WHEREAS, the Township of Bloomfield has reviewed the Statements of Qualifications submitted in response to the Township's RFQ; and

WHEREAS, The Township pursuant to the RFQ, no proposes to qualify PEM Law LLC to be eligible to serve as outside Labor Counsel and eventually enter into professional services contracts with same on a project matter; and

WHEREAS, the Director of Finance shall certify the availability of the funds to pay such contract(s) for outside Labor Counsel when such services are ordered; and

WHEREAS, said Labor Counsel contract may be awarded without public bidding as a professional services in accordance with N.J.S.A. 40A:11-5(a) of the Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq. on condition that a resolution authorizing such contracts without competitive bidding and the contracts themselves be made available for public inspection.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council, of the Township of Bloomfield, County of Essex, State of New Jersey as follows:

1. The Township is hereby authorized, on a needed basis, to enter into professional services contracts with PEM Law LLP for the provision of outside Special Legal Counsel services during the calendar year 2026.
