**RESOLUTION: AWARD OF CONTRACT FOR DISPOSAL OF VEGETATIVE WASTE
2026**

WHEREAS, sealed bids were received by the Purchasing Committee of the Township of Bloomfield for hauling and disposal of vegetative waste, on November 12, 2025 in the Council Chambers of the Municipal Building, Bloomfield, New Jersey; and

WHEREAS, a total of three bids were received with the lowest responsible bid being provided by the following:

27 Andrews Drive
Woodland Park, New Jersey 07424 Bid Amount: \$145,500; and

WHEREAS, all bids were referred to the Township Director of Public Works & Park Maintenance; and

WHEREAS, the bid proposals indicate that award of the bid should be based upon the sum of Items 1 and 2; and

WHEREAS, the Township Director of Public Works & Parks Director after due consideration recommends that the contract be awarded to Environmental Renewal, 27 Andrews Drive, Woodland Park, New Jersey 07424 at the unit prices for Items 1 and 2 for a total amount not to exceed \$145,500; and

WHEREAS, the Director of Finance has indicated that funding is available within the operating budget of the Department of Public Works.

NOW, THEREFORE BE IT RESOLVED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey that in accordance with the recommendation of the Township Director of Public Works & Park Maintenance that the

contract for hauling and disposal of vegetative waste is hereby awarded to Environmental Renewal, 27 Andrews Drive, Woodland Park, New Jersey 07424 at the unit prices for Items 1 and 2 for a total amount not to exceed \$145,500.
