2018 RESOLUTION CHANGE ORDERS

RESOLUTION: CATCH BASIN & MANHOLE UPGRADE PROGRAM - CHANGE ORDER NO. 1 - FINAL

WHEREAS, the Township of Bloomfield entered into a contract for Catch Basin and Manhole Repairs with Stanziale Construction, LLC, P.O. Box 2597, Bloomfield, NJ 07003 (hereinafter "the Contractor"); and

WHEREAS, the total contract price for this project was \$55,856.00; and

WHEREAS, during the course of construction, additional work was required when additional locations where catch basins and manholes were found to need upgrades to maintain proper drainage and safety; and

WHEREAS, the Township Engineer determined it was beneficial to have these additional locations added to this contract to expedite the repairs; and

WHEREAS, these changes resulted in an increase in the contract price of \$10,769.00 or 19 percent; and


WHEREAS, this Change Order was found to be beneficial and necessary; and

WHEREAS, the Chief Financial Officer certifies that funding is available within Capital Account No. C-04-55-716-987.




