**2018 RESOLUTION REFUND**

**RESOLUTION APPROVING THE REFUND OF \$168.40 FOR A UCC PERMIT FOR THE PROPERTY LOCATED AT 43 ALBERT TERRACE, BLOOMFIELD, NJ 07003**

**WHEREAS**, the Construction Official of the Township of Bloomfield is satisfied that the fee for the UCC Permit for the property known as 43 Albert Terrace, Bloomfield, NJ 07003 was paid, the owner has cancelled their order for the roof top solar panels, and therefore deems the applicant is entitled to a \$168.40 refund.; and
