2018 RESOLUTION AWARD OF CONTRACT

2018 RESOLUTION EMERGENCY REPAIR AUTHORIZATION

WHEREAS, the Township of Bloomfield had an emergency need to have vendors provide Emergency Repairs to the sewer at Broad Street between Watchung Avenue and Winding lane due to a sewer collapse that took place on Monday, December 18, 2017; and

WHEREAS, the Township awarded an emergency contract for the Services to Montana Construction, 80 Contant Avenue, Lodi, New Jersey 07644 (the vendor), pursuant to the provisions of N.J.S.A. 40A:11-6; and

WHEREAS, the determination was made by the township's Licensed Sewer Operator, Anthony Marucci that this was considered an emergency situation in that flow could not be maintained in the sewer main and failure to act immediately would result in a major back-up of raw sewerage into residences, businesses and onto the street, creating a risk to public health and safety; and

WHEREAS, the emergency work commenced on December 18, 2017 and was substantially completed on January 10, 2018. The work was overseen by the Mr. Marucci as well as the Bloomfield Engineering Department. Aspects of the work included:

- Emergency bypass pumping performed on a 24/7 basis to prevent back-up of sanitary sewage.
- Video camera inspection to determine the condition as well as location of the sewer break.
- Excavation to install approximately 100 linear feet of new sewer line at a twelve foot depth.
- Installation of four 12-foot deep manholes to properly align the new sewer to avoid PSE&G utility poles that were constructed critically close to the failed and broken line.
- Installation of three new house service connections to the new sewer line.

- Backfill, compaction and installation of new roadway asphalt to restore the repair area.
- Police traffic direction to maintain proper and safe traffic flow and protection throughout the duration of the work; and

WHEREAS, the final cost of the emergency work was \$315,562.18; and

WHEREAS, the Chief Financial Officer has certified the availability of funds to pay the contract in capital account C-04-55-727-987; and


WHEREAS, pursuant to the provisions of N.J.S.A. 40A: 11-6 and the Township Code, the approval of the Council of the Township of Bloomfield is required in order to make payment to the vendors, for the contract price of the Services;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE TOWNSHIP OF BLOOMFIELD:

1. That payment to the vendor made part hereof, of the contract prices for the Emergency Repairs to the sewer at Broad Street between Watchung Avenue and Winding in the aggregate amount not to exceed \$315,562.18 are hereby approved.
2. That said payment represents the total cost of the work.
3. That the Clerk of the Township of Bloomfield forward two (2) certified copies of this resolution to the Chief Financial Officer and one copy to the Township Engineer.


