2018 RESOLUTION APPROVAL

RESOLUTION: AUTHORIZING THE AWARD OF A NON-FAIR AND OPEN 2018 CONTRACT FOR CODIFICATION SERVICES

WHEREAS, the Township of Bloomfield needs to hire a company to reexamine and update the Township Code; and

WHEREAS, the Township desires to make this appointment under the provisions N.J.S.A. 19:44A-20.5, as a non-fair and open contract; and

WHEREAS, the Township Municipal Clerk has determined that the value of these services will exceed \$17,500; and

WHEREAS, this contract will end on December 31, 2018; and

WHEREAS, General Code has completed and submitted the attached Business Entity Disclosure Certification which certifies that they have not made any reportable contributions to a political or candidate committee in the Township of Bloomfield in the previous one year, and that the contract will prohibit General Gode from making any reportable contributions through the duration of this contract; and

WHEREAS, the Director of Finance has certified that funds will be available to cover the cost of this service account out of capital monies and not to exceed the amount of \$26,000.00

NOW, THEREFORE, BE RESOLVED, that the Mayor and Council of the Township of Bloomfield authorizes the Township Administrator to enter into a contract with General Gode as described herein; and

BE IT FURTHER RESOLVED, that the Business Disclosure Entity Certification, the Township Administrator's Determination of Value, the proposal of General Gode and the contract itself be placed on file with this resolution; and


BE IT FURTHER RESOLVED, that the above documents shall be available for public inspection at the office of the Township Clerk during regular business hours; and

BE IT FURTHER RESOLVED, that in accordance with Standardized Submission Requirements the Township reserves the right to cancel this contract upon thirty (30) days notice and the Professional shall only be paid for the work completed or on a pro-rated amount if the contracts calls for a monthly retainer; and

BE IT FURTHER RESOLVED, that a notice of this action shall be printed once in the official newspaper of the Township of Bloomfield.
