**RESOLUTION: AMENDMENT TO THE BLOOMFIELD PARKS, RECREATION & CULTURAL AFFAIRS DEPARTMENT'S SUBSTANCE ABUSE POLICY FOR TRANSPORTATION DRIVERS**

**WHEREAS**, the Bloomfield Recreation Department administers a Commuter Shuttle Bus Program, in conjunction with NJ Transit, to the Bloomfield Train Station;

**WHEREAS**, the Bloomfield Recreation Department views the safety and wellbeing of our passengers, drivers and fellow commuters as a paramount priority when administering this program;


**WHEREAS**, the Federal Transit Authority requires all entities that administer such programs implement a Substance Abuse Policy for Safety Sensitive Employees in accordance with 49CFR, Part 40 and Part 655;

**WHEREAS**, Bloomfield Recreation Department has a current Substance Abuse Policy that was approved on 4/18/13 but now has updated several portions of this policy to remain in compliance with 49CFR, Part 40 and Part 655;


