2018 RESOLUTION CHANGE ORDERS

SIX POINTS INTERSECTION IMPROVEMENT PROJECT - ALSO KNOWN AS THE BLOOMFIELD AVENUE INTERSECTION IMPROVEMENTS, FEDERAL HIGHWAY PROJECT NO. TCP-7672 (123) CON

WHEREAS, the Township of Bloomfield entered into a contract for the Six Points Intersection Improvement project with AJM Contracting, Inc., 300 Kuller Road, Clifton, NJ 07011 (hereinafter "the Contractor"); and

WHEREAS, this project is partially funded by a grant from the Federal Highway Administration under the Transportation & Community System Preservation Program; and

WHEREAS, the total contract price for this project was \$1,554,439.00; and

WHEREAS, during the course of construction, additional work was required due to unforeseen subsurface conditions including old, abandoned underground vaults, unforeseen utility conflicts and the need for additional maintenance and protection of traffic; and

WHEREAS, the time of completion of the project required an extension due to further coordination with other agencies and private utility companies; and

WHEREAS, these changes resulted in an increase in the contract price of \$49,491.38 or 3.2 percent, as well as an extension of the time of completion to October 3, 2016; and

WHEREAS, it is the opinion of the Bloomfield Township Engineer as well as the project consultant, ARH Associates, that these changes were needed to complete the project; and

WHEREAS, the Mayor and Council, based on the recommendation of the Township Engineer is satisfied that the Change Order should be approved; and

WHEREAS, this Change Order was found to be beneficial and necessary; and

WHEREAS, the Chief Financial Officer certifies that funding is available within Township Capital Grant Account Nos. G-02-40-302-005 and G-02-40-302-011, as well as Township Capital Account C-04-55-873-965, C-04-55-724-965 and C-04-55-703-.

NOW THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey that Change Order No. 1 - Final is hereby approved and the Financial Officer of the Township of Bloomfield is hereby authorized to adjust payment for this work.
