2019 RESOLUTION APPROVAL

2019 RESOLUTION - REJECTION OF BIDS FOR THE RENOVATION OF 348 FRANKLIN STREET TO BE USED AS OFFICES FOR THE BLOOMFIELD HEALTH DEPARTMENT (RE-BID)

WHEREAS after the required legal advertising was published, sealed bids were received in the Council Chambers of the Municipal Building, Bloomfield, New Jersey on June 11, 2019 by the Purchasing Committee of the Township of Bloomfield in accordance with N.J.S.A. 40A:11-1 et seq., "Local Public Contracts Law" for the Renovation of 348 Franklin Street To Be Used As Offices For The Bloomfield Health Department; and

WHEREAS, a total of two (2) bids were received and opened with the lowest, bid being submitted by Mountaintop Construction, Towaco, New Jersey at a total contract amount of \$787,226.75; and

WHEREAS, all bids were forwarded to the project consulting architect for review and recommendation; and

WHEREAS, after review by the project architect it was determined both bids exceeded the estimated cost for the work and the amount budgeted by the township for this project; and

WHEREAS, this project was originally bid on February 5, 2019; and;

WHEREAS, all bids were also rejected at that time because the lowest bid far exceeded the amount of funds that were budgeted for this project; and

WHEREAS, based upon the recommendation of the project architect, it is the recommendation of the Township Engineer that all bids, once again, be rejected.

NOW THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Township Of Bloomfield, County of Essex, State of New Jersey hereby reject all bids for the Renovation of 348 Franklin Street.




