**2019 RESOLUTION APPOINTMENT**

**RESOLUTION: APPROVING THE HIRE OF SIX PER DIEM/SEASONAL WORKERS FOR RECREATION PROGRAMMING**

**WHEREAS**, the Township Administrator is responsible for the day to day business operations of the Township of Bloomfield; and

**WHEREAS**, within the Township of Bloomfield, the Recreation Department hosts various programming and special events and is required to adequately staff those programs and events conducted throughout the year; and

**WHEREAS**, on January 28, 2019 the Mayor and Council passed resolution # 7429 authorizing the Township Administrator to hire per diem/seasonal workers for the recreation program; and

**WHEREAS**, the below listed individuals are per diem/part-time recreation department employees who will not be entitled to work overtime and will not receive health benefits as per diem/part-time staff; and

**WHEREAS**, the Finance Director has certified that funds are available to approve these positions.






