2019 RESOLUTION CHANGE ORDERS

2019 RESOLUTION - 2015-2016 NJDOT MUNICIPAL AID PROJECT - JFK DRIVE AND MYRTLE STREET INTERSECTION IMPROVEMENTS AND RESURFACING OF JFK DRIVE - CHANGE ORDER NO. 1 - FINAL

WHEREAS, the Township of Bloomfield entered into a contract for the 2015 - 2016 NJDOT Municipal Aid Project - JFK Drive And Myrtle Street Intersection Improvements & Resurfacing Of JFK Drive with J.A. Alexander, Inc., 130 John F. Kennedy Drive, North, Bloomfield, NJ 07003 (hereinafter "the Contractor") for a total contract amount \$590,803.27; and

WHEREAS, during the course of construction, additional work was requested including adjustments to contract quantities to meet unforeseen, subsurface site conditions, as well as additional maintenance & protection of traffic; and

WHEREAS, Change Order No. 1 - Final represents an increase in the cost of the contract in the amount of \$54,091.20 or 9.2 percent; and

WHEREAS, the Change Order request was reviewed by the project consultant and determined to be necessary for the proper completion of the project and was recommended for approval; and


WHEREAS, the Mayor and Council, based on the recommendation of the Township Engineer is satisfied that the Change Order should be approved; and

WHEREAS, this Change Order was found to be beneficial and necessary; and

WHEREAS, the Chief Financial Officer certifies that funding is available within the NJDOT municipal aid grant funding as well as roadway capital accounts C-04-55-732-002.


