**2019 RESOLUTION TAX APPEALS**

---

**RESOLUTION: AUTHORIZING THE TOWNSHIP ASSESSOR TO TAKE CERTAIN  
ACTIONS TO PROSECUTE AND DEFEND TAX APPEALS**

**WHEREAS**, the deadline for the filing of all tax appeals, either by taxpayers or the municipality, is April 1, 2019; and

**WHEREAS**, the owners of certain real property located in the Township Bloomfield will be filing tax appeals for the year 2019 with the Essex County Board of Taxation and the Tax Court of New Jersey on the allegation that these certain properties are not assessed at an amount reflecting their fair and equitable value; and

**WHEREAS**, after carefully investigating those tax appeals which are filed against the Township before the Essex County Board of Taxation and the Tax Court of New Jersey, the Township Assessor may determine that the market value of the property in question may not exceed the equalized assessment, after the application of the appropriate ratio and therefore, the assessment may be inadequate in its contribution to the Township's ratable base; and

**WHEREAS**, after carefully reviewing the assessments of other properties, the Township Assessor may determine that the assessments are erroneous and/or not indicative of the properties' fair market value and therefore need to be corrected by way of a tax appeal to the Essex County Board of Taxation and the Tax Court of New Jersey; and

**WHEREAS**, the assessment of such properties must be defended and/or revised to

**WHEREAS**, it is the desire of the Mayor and Township Council to authorize the Township Attorney and/or Special Tax Counsel to file counterclaims and municipal appeals as deemed by the Township Assessor to be necessary.

**NOW, THEREFORE, BE IT RESOLVED** by the Township Council of the Township of Bloomfield, in the County of Essex and State of New Jersey, as follows:

1. The Township Assessor and/or Special Tax Counsel are hereby authorized to direct the filings in appeals to the Essex County Board of Taxation and/or the Tax Court of New Jersey, including without limitation the filing of answers and/or counterclaims, and such other pleadings as they may deem necessary to ensure the assessments of property within the municipality are at a fair and equitable value.
2. The Township Attorney and/or Special Tax Counsel are hereby authorized to file municipal appeals to correct erroneous and/or inaccurate assessments as deemed to be necessary and in the best interest of the fiscal integrity of the Township.
3. This resolution shall take effect immediately and retroactively applies to January 1, 2019.
