2019 RESOLUTION APPROVAL

2019 RESOLUTION - WATERMAIN LOOPING PROGRAM PHASE 2 - CHANGE ORDER NO. 3 - FINAL

WHEREAS, the Township of Bloomfield entered into a contract for the Watermain Looping Program - Phase 2 with Reivax Contracting Corp., 356 Thomas Street, Newark, NJ 07114; for a total contract amount of \$426,399.00; and

WHEREAS, during the course of the project, it was necessary to adjust or modify the amount of construction items to account for unforeseen site conditions, including time delays for removal of utilities by others; and

WHEREAS, the Township Engineer and the project consultant, The Alaimo Group, have reviewed the changes enumerated in Change Order No. 3 - Final and recommend the Change Order be approved; and

WHEREAS, Change Order No. 3 represents an increase in the cost of the contract in the amount of \$12,292.88 for a revised contract amount of \$510,156.12 or a total increase of 19.6% to the original contract price, including Change Order Nos. 1& 2; and

WHEREAS, funding is available within the Township Water Utility Capital Account No. W-06-55-592-500; and

WHEREAS, the Mayor and Council, based on the recommendation of the Township Engineer, is satisfied that the specified changes should be approved; and


WHEREAS, this Change Order was found to be beneficial and necessary; and

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey that Change Order No. 3 - Final is hereby

approved and the Financial Officer of the Township of Bloomfield is hereby authorized to adjust payment for this work.


