**2017 RESOLUTION APPROVAL**

**IDA - RUN OUT SERVICES**

**WHEREAS**, the Township no longer utilizes Insurance Design Administrators ("IDA") as its benefits administrator, having approved Cigna for 2017; and

**WHEREAS**, IDA continues to provide Run Out Services per their Service Agreement with the Township during the 12 months following the termination of then Agreement; and

**WHEREAS**, the Township is obligated to pay Run Out Fees for these services as follows:

Access fees \$17.00 PEPM x 580 employees x 2 months equals \$19,720.00


