2017 RESOLUTION AWARD OF CONTRACT

AUTHORIZING THE AWARD OF A NON-FAIR AND OPEN 2017 CONTRACT-CONTINUAL FOR POLICE DEPARTMENT DIGITAL EMERGENCY RESPONSE SYSTEM SUPPORT SERVICES WITH VITAL CLICK

WHEREAS, the Township of Bloomfield needs support for its fingerprint system; and

WHEREAS, the Township desires to make this appointment under the provisions *N.J.S.A. 19:44A-20.5*, as a non-fair and open contract; and

WHEREAS, the Police Director has determined that the value of these services will not exceed \$5,500; and

WHEREAS, Vital Click, has completed and submitted the attached Business Entity Disclosure Certification which certifies that he has not made any reportable contributions to a political or candidate committee in the Township of Bloomfield in the previous one year, and that the contract will prohibit Vital Click from making any reportable contributions through the duration of this contract; and

WHEREAS, the Director of Finance has certified that funds are available to cover the cost of this service in account# 7-01-20-707-024.

NOW, THEREFORE, BE RESOLVED, that the Mayor and Council of the Township of Bloomfield authorizes the Police Director to enter into a contract with Vital Click as described herein.




