**2017 RESOLUTION AWARD OF CONTRACT**

**AUTHORIZING THE AWARD OF A NON-FAIR AND OPEN 2017 CONTRACT FOR TOWNSHIP RECREATION DEPT. CITIZEN ON-LINE REGISTRATION SOFTWARE SERVICES WITH COMMUNITY PASS DBA CAPTUREPOINT**

**WHEREAS**, the Township of Bloomfield needs to continue the services of on-line registration services for the Recreation department for the township; and

**WHEREAS**, the Township desires to make this appointment under the provisions *N.J.S.A. 19:44A-20.5*, as a non-fair and open contract; and

**WHEREAS**, the Township Administrator has determined that the value of these services will cost approximately \$5,000 and will not exceed \$5,000; and

**WHEREAS**, CAPTUREPOINT, has completed and submitted the attached Business Entity Disclosure Certification which certifies that he has not made any reportable contributions to a political or candidate committee in the Township of Bloomfield in the previous one year, and that the contract will prohibit CAPTUREPOINT from making any reportable contributions through the duration of this contract; and

**WHEREAS**, the Director of Finance has certified that funds are available to cover the cost of this service in account# 7-01-20-707-029; and

**NOW, THEREFORE, BE RESOLVED**, that the Mayor and Council of the Township of Bloomfield authorizes the Township Recreation Director to enter into a contract with CAPTUREPOINT as described herein.






