**2017 RESOLUTION AWARD OF CONTRACT**

**AWARD OF RE-NEGOTIATED CONTRACT FOR THE COLLINS HOUSE  
STABILIZATION - PHASE 2**

**WHEREAS**, on November 21, 2016, the Mayor and Council adopted a resolution awarding a negotiated contract to Three Sons Restoration, LLC, 1235 Morris Avenue, Union, NJ 07083 in the amount of \$42,705.00; and

**WHEREAS**, during the course of preparing the necessary contract documents, Three Sons Restoration, LLC, was unable to acquire the necessary insurance coverage as specified in the bid documents and could therefore not execute or enter into a contact with the Township of Bloomfield for the above referenced work; and

**WHEREAS**, the second qualified bidder who provided a negotiated price for this work was Precision Building and Construction, 216 Somerset Street, Bridgewater, New Jersey 08805 at a contract price of \$50,600.00; and

**WHEREAS**, it was determined by the Township Engineer that Precision Building and Construction was available and qualified to perform the above work and possessed the appropriate contract requirements; and

**WHEREAS**, it is the recommendation of the Township Engineer, that the original award of a contract to Three Sons Restoration, LLC, 1235 Morris Avenue, Union, NJ 07083 in the amount of \$42,705.00 be rescinded due to failure of the awarded contractor to execute a contract; and

**WHEREAS**, that the contract be awarded to the second bidder, Precision Building and Construction, 216 Somerset Street, Bridgewater, New Jersey 08805 at the negotiated price of

\$50,600.00 and

BE IT FURTHER RESOLVED, that the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey hereby authorize the Township Engineer to enter into a contract with Precision Building and Construction, 216 Somerset Street, Bridgewater, New Jersey 08805 at a contract price of \$50,600.00 as permitted by N.J.S.A. 40A:11 for The Collins House Stabilization - Phase 2.

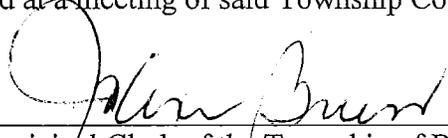

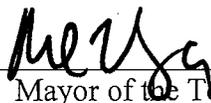
